

# **Utah Residency Reclassification Application**

There are different tuition rates for Utah residents

and nonresidents, based on the Utah State Law, 53B-8-102 and the Board of Regents R512, Policies and Procedures. Your initial residency classification is made when you are admitted and will be included in your official letter of acceptance. If you are classified as a nonresident and feel you should qualify for resident status, you may submit an Application for Residency Reclassification with the appropriate supporting documents.

# **Residency Guidelines and Checklist**

Applications for residency status are accepted no later than the end of the third week of the term reclassification is requested

## According to Utah State Legislation R512 you may qualify for Utah resident tuition if:

You are a United States citizen; or applied for or granted permanent resident, refugee, asylum, or temporary protected status

#### AND

- Domicile documents required for all applicants
  - 1. Utah driver's license
  - 2. Utah voter registration
  - 3. Utah vehicle registration

#### **AND**

➤ Have lived in Utah for twelve (12) or more continuous months immediately preceding the term for which you are applying without leaving Utah for a **total** of more than 29 days during the twelve months.

## REQUIRED:

- Completed application
- 2. Proof of physical presence for 12 months (suggestions for proof on next page)
- 3. Financial independence. Tax return of student or parent (if student is under 24 years old) showing student was not claimed on any person's tax return for the prior tax year who lives outside of Utah (see Note below).

OR

> Student's full-time permanent employment.

## REQUIRED:

- 1. Completed application
- 2. Proof of permanent full-time employment four months prior to applying to SUU OR
- Parent moved to Utah for permanent full-time employment (student is under 24 years of age).

#### REQUIRED:

- 1. Completed application
- 2. Parent's Utah employment verification
- 3. Parent's Utah home rental/lease/purchase verification
- 4. Parent's Utah domicile documents (1-3)
- 5. Student's domicile documents (1-3)

OR

> Dependent child of a Utah resident who has lived in Utah for 12 or more months (student is under 24 years of age).

#### REQUIRED:

- Completed application
- 2. Proof of parent(s)' Utah resident for 12 or more months
- 3. Parent's Utah home rental/lease/purchase verification
- 4. Parent's Utah employment verification
- 5. Parent's Utah domicile documents (1-3)
- 6. Student's domicile documents (1-3)

OR

Married to a Utah resident

#### REQUIRED:

- 1. Completed application and verification of spouse's Utah residency
- 2. Spouse's Utah driver's license
- 3. Spouse's Utah voter registration
- 4. Spouse's Utah vehicle registration
- 5. Copy of the marriage certificate
- 6. Student's domicile documents

OF

Active duty military personnel stationed in Utah, including Utah National Guard;

#### REQUIRED (Note: no application is required):

- 1. Military ID for military personnel and dependent (if the dependent is the student)
- Most recent orders showing the assignment to Utah

Additional criteria on reverse side

OR

➤ Military Veteran serving 180 days or more with an honorable or general discharge;

### REQUIRED:

- 1. Completed application
- 2. Copy of DD 214
- 3. At least **one** of the following:
  - a. Student's Utah driver's license
  - b. Student's Utah voter registration
  - Student's Utah vehicle registration
  - d. Utah employment
  - e. Utah lease agreement with veteran's name and Utah address
  - f. Utility bills shown veteran's name and Utah address

OR

> Dependent of a veteran;

#### REOUIRED:

- 1. Completed application
- 2. Copy of parent/guardian DD 214 showing the separation date
- 3. Proof of dependency: birth certificate, tax return, military ID, etc.
- 4. At least **one** of the following:
  - a. Student's Utah driver's license
  - b. Student's Utah voter registration
  - c. Student's Utah vehicle
  - d. Utah employment
  - e. Utah lease agreement with veteran's name and Utah address
  - f. Utility bills shown veteran's name and Utah address

OF

Other criteria as outlined in R512.

NOTE: Verification of financial independence showing that you are not claimed as a dependent on the tax return of any person who is not a resident of Utah is required for reclassification applicants using the 12 month rule.

- \* If you are single and 23 years of age or younger, provide a copy of the first two pages of your federal tax return (Form 1040) for the tax year prior to the academic year for which you wish to qualify for resident student status.
- \* If you did not file a federal return or someone else could claim you as a dependent, provide a copy of the first two pages of your parent(s) federal tax return(s) (Form 1040) for the tax year prior to the academic year for which you wish to qualify for resident tuition.
- \* Western Undergraduate Waiver (WUE) recipients will not be eligible to apply for residency reclassification for tuition purposes. (Exceptions are: marriage to a Utah resident, joining the Utah National Guard, or parents are Utah residents).
- \* Students in the U.S. on any type of visa are not eligible for reclassification as Utah residents for tuition purposes.

Adverse rulings may be appealed by submitting a written request to the Residency Appeals Committee. The Committee shall make an independent examination of the issues presented and shall make a final determination of the resident status. Appeals may be given to the Admissions Office for submission to the Committee.

# Verification for the 12 Month General Rule

Applicants for reclassification under the 12-month general rule have the responsibility to prove that you have physically resided in Utah for 12 continuous months without absences totaling more than 29 days. Some suggestions for verification may include, but are not limited to, any or all of the following:

- School attendance in face-to-face classes. Transcripts will be used for this method.
- Employment history (pay stubs or letter from employer must clearly state the number of days worked each week and that the employment has been consistent without breaks in attendance). Pay stubs will be reviewed for hours worked each pay period. Part time employment may require additional verification depending on the hours worked or statement from the employer.
- Bank statements with the student's name showing daily activity in Utah.
- Cell phone records showing origination of calls in Utah.
- Gym membership and official work out log.
- Volunteer service records with activity dates.
- Letter from professors, coaches, community, business, or religious leader (must state clearly that there has been consistent and daily interaction during the time in question)
- Other verification that verifies physical presence

NOTE: **Rental agreements, rent receipts, or utility bills do <u>not</u> show physical presence**. They may be submitted, but additional documents will be required. In addition, receipts for purchases in the state will not be accepted as prove of physical presence. These items are suggestions only. If students are unable to provide any of the items above, it is his/her responsibility to provide acceptable method that will prove physical presence. Statements from family, friends, neighbors, etc will be accepted, but additional items will be required.

INSTRUCTIONS: Residency criteria for tuition purposes are defined by Utah State law. Please read and carefully consider all questions before attempting to answer any of them. Supplementary information and/or documentation will have a bearing on the status determination are required. All requests for resident classification are processed in the order in which they are received. You must be admitted and/or permitted to enroll for the semester in which you are requesting resident status. Please allow at least two weeks for action on your application. You will be notified by email if additional information is needed or as soon as a decision is reached concerning your eligibility.

NOTE: Applications are accepted for review after August 1<sup>st</sup> for Fall Semester and December 1st for Spring Semester and before the fourth week of the semester you are requesting a residency change. Applications submitted more than 21 days after the start of the semester may not be considered for the current academic term. General questions may be directed to the SUU Admissions Office; final decisions are made by the SUU Residency Officer. If you have questions about residency, please email residency@suu.edu
